

Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility

ENTV Promotional Giveaway (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry and able to provide a non PO Box mailing address if selected as winner. Employees of Movieline.com LLC, PMC, and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Subject to all applicable federal, state, and local laws and regulations. Void in Puerto Rico and where prohibited. During the Promotion Period, http://www.youtube.com/subscription_center?add_user=ENTV and subscribe to the ENTV YouTube channel. You must be subscribed to the ENTV YouTube channel at the time of the winner selection to be qualified. You automatically will receive one (1) entry into the drawing for the applicable Entry Period. Limit: Each participant may enter only once during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified.
